New Money Only is money that is not already on deposit in the Credit Union. Funds on deposit can not be withdrawn and re-deposited. The Credit Union reserves the right to make the sole judgment as to whether or not the deposited funds are considered new money.
Receipt of Truth-In-Savings Disclosure: By signing this application, I/we acknowledge that I have received a copy of the Fee Schedule and the brochure "About your Credit Union Accounts" containing the Truth-In-Savings Disclosures and Privacy Notice. I/We agree to be bound by the terms and conditions of the Credit Union's Accounts Agreement(s) and any amendments thereto. If I/we are not present at the credit union when the account is opened, the credit union will mail the above Disclosures and Fee Schedule to me within twenty days after the account is opened.
Deposit Insurance Disclosure: By signing this application I/we acknowledge that Christian Community Credit Union (CCCU) is privately insured by American Share Insurance up to \$250,000 per account. Christian Community Credit Union is not federally insured and if the credit union fails, the federal Government does not guarantee that deposits will get back their money.
