

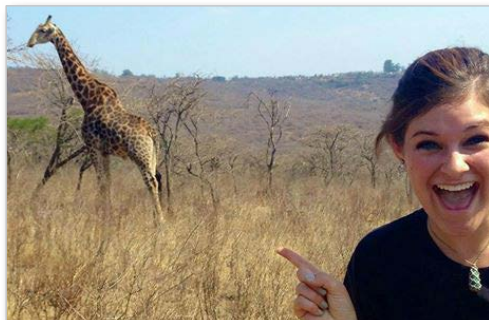

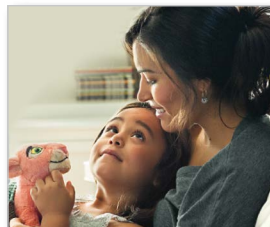
You can still donate your CURewards points to the mission projects below through January 31, 2015. Every 10,000 points you give results in a \$70 donation.

Visa Cardholder Notice Three Important Changes Coming!

We are converting all Visa credit cards to new smart cards with embedded computer chips to improve security. Here are three changes coming to your Visa card in January 2015!

- 1. New Card, New Number:** Your card number and expiration date will change; we'll issue you a new card in January 2015.
- 2. Improved Security:** Your new Visa credit card will include an embedded chip which will improve security when you make purchases at a chip-enabled terminal. This chip will help protect your personal information and will make fraudulent charges much more difficult.
- 3. Enhanced Benefits:** Your new card will include all the same benefits you currently receive, plus more! Also, your CURewards points will automatically transfer to your new Visa credit card.
