In 2022, we welcomed 2,637 new members to the CCCU family, allowing us to serve over 29,000 members nationwide. Following the rebrand reveal and rollout, our website underwent a major makeover with a modern look, improved navigation, and mobile-friendly functionality. To provide members and prospective members with an optimal experience, we streamlined our online credit card, auto, and personal loan applications. Our digital banking platform has been enhanced, enabling members to manage their credit cards more efficiently within our mobile banking app. Plus, we introduced Zelle,<sup>®</sup> a fast and easy way to send money to friends and family.

#### Supporting Missions and Advancing God's Kingdom

Congratulations! Through your usage of our "Cards that Give to Missions," **we've been able to donate over \$6 million dollars to date!** In 2022, CCCU gave to Christian causes that share Christ's love to isolated areas; rescue those trapped in modernday slavery; care for orphans and foster youth; and provide disaster relief, among others. 
